Now, therefore the undersigned in exercise of powers conferred by Subrule-1(a) of Rule-12 of O.C.S (CCA) Rules 1962 hereby places Sri Binod Kumar Digal, Auditor, LFA O/o the DAO, LFA, Phulbani under suspension with immediate effect.

It is further ordered that during the period of suspension, the Head-quarters of Sri Digal, Auditor shall be at O/o the DAO, LFA, Rayagada and he shall not leave the Head-quarter without prior permission of the District Audit Officer, LFA, Rayagada.

Subsistence allowance as admissible U/R-90(1) (a) of Odisha Service Code is sanctioned in favour of Sri Digal for a period of Six months with effect from the date of his suspension subject to furnishing a Certificate to the District Audit Officer, LFA, Rayagada that he has not been engaged in any employment, business of profession during the period of suspension.


