Sub: Cadre Restructuring of Audit Personnel under Local Fund
Audit Organisation, Odisha.

At present Local Fund Audit Organisation is running with total cadre strength of 769. In order to have greater supervisory effect and for strengthening the Local Fund Audit in different organisations, the cadre necessitated restructuring at the supervisory level.

2. After careful consideration, Government have been pleased to upgrade 77 (Seventy Seven) posts of "Local Fund Auditor" in Level-9 as per ORSP Rule, 2017 in the following manner.

3. Due to up-gradation of 77 (Seventy Seven) posts of "Local Fund Auditors" to different ranks as stated above, required number of 77 (Seventy Seven) no. of posts of Local fund Auditor stand abolished at the base level reducing the cadre strength of Local fund Auditors to 570. After such up-gradation/abolition, the relocation of different Local Fund Audit personnel is at Annexure-I.


4. The posts so created at the supervisory level i.e., 67 no. of posts of Audit Superintendent and 10 no. of Additional District Audit Officers are to be filled up on observance of due promotional procedures as outlined in the Odisha Local Fund Audit Act/ Rules.
