**OFFICE MEMORANDUM**

**Sub: Grant of Conveyance Allowance for Deaf and Dumb employees of State Government.**

In Finance Department O.M. No.-14867/F dt-17.04.2013, the Conveyance Allowance payable to the Blind and Physically handicapped persons serving under State Government was fixed at the flat rate of Rs 350/- per month.

2. In the meantime Government of India, Ministry of Finance, Department of Expenditure have extended the benefit of Transport Allowance to the Deaf and Dumb employees of Central Government in their Office Memorandum. No.- 21(2) 2011-E-II(B) dated 19.02.2014.

3. The demands for extending the same benefit to the Deaf & Dumb employees of the State Government raised by the Deaf and Dumb State Government employees of Odisha association was under consideration of Government. After careful consideration, the State Government have now decided to extend the benefit of Conveyance Allowance at a flat rate of Rs 350/- (Rupees Three Hundred and Fifty) only per month for Deaf and Dumb State Government employees.

4. The grant of Conveyance Allowance under this order shall be subject to the following conditions:-

(i) The allowance shall not be admissible to those Deaf & Dumb employees who are provided with Government accommodation within a distance of one kilometer from the place of work of his/her residence or the place of work and his/her residence are in the same campus.

**Note:** The grant of the allowance under these orders would be subject to furnishing of a certificate by the employee that the Government accommodation is not located within one kilometer from the place of work of the concerned employee or within a campus housing the places of work and residence.

(ii) The allowance shall not be admissible to those employees who have been provided with the facility of Government transport.

(iii) This allowance will not be admissible during absence from duty exceeding 30 days due to leave, training, tour etc.

These orders shall take effect from the date of issue.
