In exercise for the Powers conferred, under the Treasury Rules 4,5,9,10,12,15,29 of the Treasury Rules (Orissa) which authorises the Finance Minister in consultation with Accountant General, Orissa to prescribe the procedure to be followed with respect to transactions in connection with the Public Account as mentioned in the Treasury Rules which are called the Subsidiary Rules under the Treasury Rules (Orissa).

The Minister, Finance after consultation with Accountant General (A & E), Odisha has decided to substitute the "FORM OF MONTHLY ACCOUNT" prescribed in the Subsidiary Rules -479 A of O.T.C. Vol-I by way of an amendment to the said Rules which is as follows :

AMENDMENT

In Subsidiary Rule-479 A, the existing "FORM OF MONTHLY ACCOUNT" shall be substituted as follows :

N:B:1. The nomenclature of each item/scheme on both the receipt and expenditure side should not be different. In other words, if the item of receipt is "X" on the expenditure side it should be "X" only. If the nomenclature of the scheme is "Y" on the receipt side, then it should be "Y" on the expenditure side.

2. In case of transfer of funds to lower level Agencies for expenditure, the words 'transfer' should be suffixed to the item of receipt/expenditure or scheme. In support of transfer U.C should follow with details of transfer i.e to whom transferred. The amount should appear in the P.L Account of recipient.

3. All the statements should be granted Scheme wise.
