Sub:- Revision of compensation / hire charges of different categories of vehicles to be deployed in the Elections/ bye -elections in Odisha .

In supersession of all previous notifications issued in this respect, Government have been pleased to revise the hiring charges of different categories of vehicles to be requisitioned by Government for different purposes .



When a vehicle is detained for more than 12 hours in any day, this will be treated as on duty for a full day and vehicles detained for less than 12 hours will be treated as on duty for a half day and compensation will be paid accordingly.

The fuel and lubricants consumed by the vehicles requisitioned for official duty will be provided by Government, i.e. the Department requisitioning the vehicle.
