## Sub: Re-constitution of Appeal Forum under Section 11 of the Odisha Local Fund Audit Act, 1948 with effect from 18<sup>th</sup> July, 2019.

Madam / Sir,

In inviting a reference to the captioned subject and enclosing copies of Govt Notification No. 24373/F, dtd. 18.07.2019 and corresponding Gazette Notification dated 18.07.2019, I am directed to say that the Appeal Forum under Section 11 of the Odisha Local Fund Audit Act, 1948 has been re-constituted with effect from 18<sup>th</sup> July 2019, i.e., the date of publication of the aforementioned Govt. Notification in the Odisha Gazette.

As per the said Notification, for the purpose of preferring appeal by aggrieved delinquents under section 11 of the OLFA Act, 1948, the surcharge cases instituted under the Act have been broken up into two categories, i.e., (i) surcharge orders in respect of surcharge proceedings initiated before 1<sup>st</sup> September, 2013 and (ii) surcharge orders in respect of surcharge proceedings initiated on or after 1<sup>st</sup> September, 2013.

Appeal forum for Surcharge proceedings initiated before 01.09.2013. In case surcharge / charge orders have been passed in respect of surcharge proceedings initiated before 01.09.2013 relating to Urban Local Bodies (ULBs) irrespective of the surcharge initiating authority, the appropriate Appellate Authority is Hon'ble Minister, Housing & Urban Development. Similarly, if surcharge / charge orders have been passed in respect of surcharge proceedings initiated before 01.09.2013 but relating to all other categories of institutions (except ULBs), the appropriate Appellate Authorities are: Deputy Examiner of Local Accounts-cum-Deputy Director, Local Fund Audit, Examiner of Local Accounts-cum-Director, Local Fund Audit, Examiner of Local Accounts-cum-Director, Local Fund Audit and Development Commissioner depending on the level of Officer who passed the surcharge order.

Appeal forum for Surcharge proceedings initiated on or after01.09.2013. In case surcharge / charge orders have been passed in respect of surcharge proceedings initiated on or after 01.09.2013, for all categories of institutions, including ULBs, the appropriate Appellate Authorities are: Deputy Examiner of Local Accounts-cum-Deputy Director, Local Fund Audit, Deputy Examiner of Local Accounts-cum-Joint Director, Local Fund Audit, Deputy Examiner of Local Accounts-cum-Additional Director, Local Fund Audit, Examiner of Local Accounts-cum-Director, Local Fund Audit, Examiner of Local Accounts-cum-Additional Director, Local Fund Audit, Examiner of Local Accounts-cum-Director, Local Fund Audit, interval and Secretary to Government, Finance Department depending on the amount involved in the surcharge / charge order.

You are therefore requested to circulate this along with a copy of the Gazette Notification among all Auditors, Audit Superintendents and Additional District Audit Officers under your control for information and guidance.

Further, it is instructed that henceforth while passing of Surcharge/Charge Order, the appropriate Appellate Authority according to the Notification dated 18.07.2019 should invariably be mentioned in the said order.
