OFFICE MEMORANDUM

Sub: Adoption of "Public Procurement (Preference to Make in India), Order 2017" of GoI by State Government of Odisha- Regarding

In national interest, Government of India, under Rule 153 (iii) of GFR, 2017 and vide Order No. P-45021/2/2017-B.E.-II dated 15.06.2017, has notified "Public Procurement (Preference to Make in India), Order 2017" to give preference to Indian suppliers of goods and services vis-à-vis foreign suppliers, in the matter of procurement of goods and services by Government organisations / entities.

Considering the national interest aspect, State Government has now decided to adopt the above-said Order of Government of India, with immediate effect. The said Order of Government of India shall be deemed to be part of OGFR and will have overriding effect on any contrary provision of OGFR.

Provisions of the above-said Order (i.e. Preference to Make in India Order) shall be followed when foreign bidders participate in procurement of any goods or services. However, this Order has no relevance/utility in any procurement process where there is no foreign bidder. Therefore, in every bid/tender advertisement for procurement of goods and/or services by any State Government organisation/entity, following clause shall mandatorily be mentioned.


"Provisions of 'Public Procurement (Preference to Make in India), Order 2017', as amended from time to time, shall be followed in case eligible foreign bidders participate in the bidding process".

(Note: It should be noted that, with effect from the date of issue of this OM, provisions of this Order shall have to be followed anyway even if the same is not mentioned in the bid/tender advertisement. However, mentioning this in the bid/tender advertisement will make the process transparent and free from future litigations.)

In case of any conflict between provisions of this Order and Odisha Procurement Preference Policy for Micro and Small Manufacturing Enterprises-2023 (notified by MSME Department) or for any other complicacy, State Government organisations/entities shall consult with Finance Department for resolution of the conflicting situation/complicacy.
