

OFFICE ORDER

In pursuance of the provisions of Odisha Group-C & Group-D Posts (Contractual Appointment) Rule, 2013 notified vide Govt. in G.A. Department Notification No.32010-GAD-SC-RULES-0009-2013/GEN dated 12th November 2013, Sonali Beura (UR-W) , Plot No.724, Behera Sahi, Nayapalli, Bhubaneswar-751012 who has been recommended by the Odisha Staff Selection Commission, Bhubaneswar vide their letter No.IIE (Conf)-4/2022-4370/OSSC dt.24.06.2022 is hereby temporarily appointed as Junior Stenographer (Initial Appointee) on contractual basis against the vacant post in the Directorate of Local Fund Audit Odisha, Bhubaneswar with consolidated monthly remuneration of Rs. 14200/-under following terms and conditions

1. Her appointment is subject to verification of their character and antecedents by the appropriate Authority. In case an adverse report is received, her services shall be terminated forthwith in accordance with the provisions laid down in sub-clause-I of clause-h of explanation under Rule, 13 of Orissa Civil Services (Classification, Control and Appeal) Rules, 1962.
2. She will be governed by the provisions of Odisha Group-C & Group-D posts (Contractual Appointment) Rules, 2013 and Amendment thereof.
3. Subject to her satisfactory performance, the consolidated monthly remuneration shall be enhanced as per slabs prescribed under Odisha Group-C & Group-D (Contractual Appointment) Amendment Rules, 2021.
4. On regular appointment, she shall be entitled to draw his pay in level-7 of the pay matrix under ORSP Rules' 2017.
5. She shall be enrolled under the New Pension Scheme contained under Odisha Civil Service (Pension) Rules, 1992 from the date of his contractual appointment
6. She should join in the office of the Directorate of Local Fund Audit, Odisha, Bhubaneswar within **thirty** days from the date of issue of this order failing which her appointment stands cancelled automatically. On no account any representation for extension of the date of joining shall be entertained.
7. She has to submit the following documents on the date of Joining in the Post.
 - (a) Medical Certificate of fitness in the prescribed Form from a Medical Officer not below the rank of an Assistant Surgeon in the State Government Service of Govt. Hospital.

- (b) All Original Certificates in support of educational qualifications and date of birth along with one set of Xerox Copies thereof duly attested by self.
 - (c) Character Certificate from two Gazetted Officers not related to her (in Annexure-I).
 - (d) A Declaration to the effect that she has not more than one spouse living in case of married person (in Annexure-II).
 - (e) A declaration to the effect that she is not prosecuting studies in any educational institution (in Annexure-III).
 - (f) A statement showing the movable and immovable property owned by her in the enclosed Form-A prescribed under the Orissa Government Servants Conduct Rules, 1959. This statement should be submitted in a sealed envelope by writing the name, designation and present address and mentioning in bold letters as "PROPERTY STATEMENT" (in Annexure-IV).
 - (g) Attestation form duly filled in with two passport size photographs duly attested by a Gazetted officer under his seal (in Annexure-V).
 - (h) An oath of allegiance to the constitution of India. (in Annexure-VI).
 - (i) Original Discharge Certificate in case of Ex- Service Man.
8. No TA will be allowed for undertaking journey to join the post/ place of posting.




