**Sub: Introduction of a new system of e-statement and push SMS
for all the G.P.F. subscribers.**

Sir/Madam,

I am directed to say that the Principal, A.G.(A&E), Odisha has developed a software with the help of N.I.C. for hosting of G.P.F. accounts of the subscribers starting with the annual statement for 2012-13.

The annual statement of G.P.F. for 2012-13 can be accessed by the subscriber through official web site of Principal A.G.(O) i.e. <http://www.agodisha.gov.in>. To view/download the statements, the subscriber is required to log in with the G.P.F. Account no. as the user-id and the default pass word will be the date of birth of the subscriber. On first attempt, the subscriber has to mandatorily register his mobile no. and change the password as a security measure. In case of subscribers, whose date of birth is not available in the database, they may forward their date of birth to the office of Principal Accountant General, A.G.(A&E), Odisha through their DDOs.

You are, therefore, requested to instruct DDOs under your control to sensitize the employees working under them on the procedures for generation of annual account slip of G.P.F. so as to maintain the confidentiality and avoid possible misuse. Henceforth, no physical account slip will be issued in favour of the subscribers.
