Inordinate delay in approval of Accounts Review Reports in respect of ARP, 2013-14.

Madam/Sir,

In inviting a reference to the captioned subject, I am to say that on review of the status of approval of accounts review reports of aided colleges relating to Annual Accounts review Programme, 2013-14, it is revealed that as on 31.10.2014 four(4) nos. of reports are pending for approval at the level of DAOs and eleven (11) nos. of reports are pending with reviewing officers (list enclosed) and some of the reports are pending for inordinately long periods. It was instructed that the reports should be approved within seven days of submission. But some reports are pending with reviewers for more than two months even after resubmission after due rectification by the C.A. Firms. It is also noticed that in some cases after relief of the reviewing officers from the District Offices, no fresh assignments have been made for review of the reports.

This shows the callous attitude on your part which is not desirable. Approval of the reports cannot be kept pending for an indefinite period. Hence you are hereby instructed to ensure approval of all the review reports pending at the level of reviewing officers and DAOs by 15<sup>th</sup> November, 2014 positively.
