1. Their appointment is subject to verification of their character and antecedents by the appropriate Authority. In case an adverse report is received, their services shall be terminated forthwith in accordance with the provisions laid down in sub-clause-I of clause-h of explanation under Rule, 13 of Orissa Civil Services (Classification, Control and Appeal) Rules, 1962.

- 2. They will be governed by the provisions of Odisha Group B posts (Contractual Appointment) Rules, 2013 and Amendment thereof.
- 3. Subject to their satisfactory performance, the consolidated monthly remuneration shall be enhanced as per slabs prescribed under Odisha Group-B (Contractual Appointment) Amendment Rules, 2021.

- 4. On regular appointment, they shall be entitled to draw their pay in level-9 of the pay matrix under ORSP Rules' 2017.
- 5. They shall be enrolled under the New Pension Scheme contained under Odisha Civil Service (Pension) Rules, 1992 from the date of their contractual appointment
- 6. They should join in the office of the District Audit Officer as indicated under col. 7 against their names within thirty days from the date of issue of this order failing which their appointment stands cancelled automatically. On no account any representation for extension of the date of joining or change in place of posting shall be entertained.
- 7. They shall have to submit the following documents on the date of Joining in the Post.

  - (g) Attestation form duly filled in with two passport size photographs duly attested by a gazetteeofficer under his seal (in Annexure-V).
  - (h) An oath of allegiance to the constitution of India. (in Annexure-VI).
  - (i) Original Caste Certificate from competent authority (in case of SC & ST/SEBC candidates).
  - (j) Original Certificate from competent Medical Authority in support of Physical Disability in case of candidate in P.H. Category.
  - (k) Original Discharge Certificate in case of Ex- Service Man.
