Sub: Removal of HDFC Bank, ICICI Bank and Axis Bank from list of banks empanelled for handling business and deposits of State Government Organisations

Madam/Sir,

This is to intimate you that due to persisting poor performance in some flagship government schemes over last two FYs, coupled with discouraging general banking parameters; HDFC Bank, ICICI Bank and Axis Bank are hereby, with immediate effect, removed from the list of banks empanelled for handling business and deposits of State Government and State Government supported organisations such as State Government Departments/ Directorates/ HoDs/ Establishments/ Agencies/ PSUs/ Societies/ Universities etc.

All these above mentioned organisations are hereby directed to immediately close their Savings Bank/ Current/ other running accounts maintained in these three banks and transfer the account balance to any new/ existing account opened or maintained in any other empanelled bank. However, Fixed Deposits/Term Deposits, etc. currently maintained in these three banks shall not be closed now as it may lead to loss of interest due to pre-mature closure. But, on maturity of these deposits, the entire deposit along with accrued interest shall be transferred to other empanelled banks.

This instruction will be made effective prospectively from the date of issue of this letter. Non-compliance to these instructions will be viewed seriously. You are, therefore, requested to kindly circulate this letter to all State Government and State Government supported organisations coming under administrative control of your respective department.
