Keeping this in view it was decided that e-reports in respect of GP audits would be table-reviewed as per Annual Audit Programme for 2013-14. In fact, supervision or progress review of GP audit is not necessary except in cases of detection of huge misappropriation, loss of stock & stores, fraud etc.
