TEONJHAR sub: Identification of willing and suitable SHGs for taking up Pisciculture in GP tanks for the year 2022-23.

Ref: (i) Letter No. 5170 dated 08.04.2022 of Directorate of Fisheries on Physical target for 'Input Assistance to WSHGs for practicing Pisciculture in GP tanks & Pvt tanks for the year 2022-23.

(ii)Letter No.280 dated 05.01.2022 of Directorate of Fisheries on Odisha Gram Panchayat (Amendment) rules, 2021

Madam/Sir,

As per the recent change in the Odisha Gram Panchayat (Amendment) rules, 2021, preference will be given to Women Self Help Groups of the same GP to participate in the auction for lease of GP tanks.

The lease period shall be at least for a period of 5 years on long term basis with annual increment of 10% in the approved bid value.

Directorate of Fisheries has communicated the physical target for the year 2022-23. This target is just notional and can be increased.

There should be concerted efforts to involve more SHGs under such sustainable activity.

In view of the above, following steps shall be taken towards involvement and

selection of more SHG to achieve more than the target fixed for 2022-23.

- i. Sensitize SHGs at GP & Block level and make them aware of the recent policy change involving the field functionaries including the community cadres.
- ii. Ensure participation of as many SHGs in the auctions for long term lease.
- iii. A GP wise list of willing SHGs be prepared immediately and their participation facilitated
- iv. Required handholding support should be provided to all willing SHGs for submission of applications before the appropriate competent authorities.
- v. Information on GP tanks listed for auction shall be collected from Blocks and shared with GPLFs and BLFs to aware the member SHGs.
- vi. Community cadres should be involved to create awareness among SHGs at the village level.
- vii. Some SHGs are into fish farming for last 3/4 years. They should also be sensitised for participation in the auctions to ensure sustainable livelihood.

Finally, release of input subsidies shall be ensured by supporting the SHGs in timely submission of vouchers etc.

It is requested to impress upon the CDPOs and BPCs to ensure timely identification of willing & capable SHGs in close coordination with field functionaries of FARD Department to achieve the target for the year 2022-23 and involve more SHGs in Pisciculture.

Madam/Sir,

With reference to the subject cited above, I am to inform you that during the year, 2022-23, the pisciculture through WSHGs will be taken up in minimum area of 5000 Ha. GP tanks & Pvt. tanks under the scheme "Input to WSHGs for practicing pisciculture in GP tanks during 2022-23".

District-wise physical target is enclosed at <u>ANNEXURE-I</u>, which is only indicative in nature. Further, you shall strive to achieve this target without fail and make an effort to achieve more if feasible Private Tanks/ GP Tanks are available in the district, adhering to the following Operational Guidelines/circulars/letter.

- ii. Covering WSHG to take up pisciculture in private tanks letter no. 11217 dated 08-09-2021 of Director of Fisheries

NOTIFICATION

The 10th December, 2021

S.R.O.No.490/2021—Whereas, the draft of certain rules further to amend the Odisha Grama Panchayat Rules, 2014 which the State Government propose to make was published as required under sub-section (1) of Section 150 of the Odisha Grama Panchayat Act, 1964 (Odisha Act 1 of 1965), in the Extraordinary issue No. 1512 of the Odisha Gazette, dated the 22nd September, 2021 under the notification of the Government of Odisha in the Panchayati Raj & Drinking Water Department No. 15846, 20th September, 2021 bearing S.R.O No.334/2021 inviting objections and suggestions from all persons likely to be affected thereby till the expiry of a period of 15 days from the date of publication of the said notification in the Odisha Gazette.

And, whereas, no objection or suggestion has been received in respect of the said draft during the stipulated period by the State Government.

Now, therefore, in exercise of the powers conferred by sub-section (1) of Section 150 of the said Act the State Government do hereby make the following rules further to amend the Odisha Grama Panchayat Rules, 2014, namely;—

AMENDMENT

- 1. (1) These rules may be called the Odisha Grama Panchayat (Amendment) Rules, 2021.
- (2) They shall come into force on the date of their publication in the Odisha Gazette.
 - 2. In the Odisha Grama Panchayat Rules, 2014, in rule 48, -
 - (i) after sub-rule (4), the following sub-rule shall be inserted, namely;—
 "(4-a) In case tanks located in the Grama Panchayat, the upset price
 fixed under sub-rule (4) shall not be less than rupees two thousand per
 acre per year.

(ii) after clause (a) of sub-rule (5), the following clauses shall be inserted, namely;—

"(a-i) In case of lease by public auction of tanks belonging to Grama Panchayat, preference shall be given to Women Self Help Groups of the same Grama Panchayat to participate in the said auction and in case no Women Self Help Group participates in the said auction process, it shall be opened to others; and

"(a-ii) The period of lease of the said tanks shall be at least for a period of five years on long term basis with annual increment of 10% in the approved bid value.".
