Subsistence allowance as admissible U/R-90(1) (a) of Odisha Service Code is sanctioned in favour of Sri Digal for a period of Six months with effect from the date of his suspension subject to furnishing a Certificate to the District Audit Officer, LFA, Rayagada that he has not been engaged in any employment, business of profession during the period of suspension.
