In pursuance of Rule-4 of the Orissa Subordinate Finance Service (Local Fund Audit) Rules, 1995 and provisions of Odisha Group-B posts(Contractual Appointment) Rules, 2013 and Amendment thereof, Sri Mahendra Sahoo , who has been recommended by the Odisha Staff Selection Commission, Bhubaneswar vide their letter No.IIE (Conf)-91/2021-2591/OSSC dt.11.05.2022 is hereby temporarily appointed as Auditor (Initial Appointee) on contractual basis in the Local Fund Audit Organization under Finance Department, Govt. of Odisha with consolidated monthly remuneration of Rs. 25300/- after successful examination by the Appellate Medical Board in SCB Medical College Cuttack .

On being appointed as Auditor (Initial Appointee), he is posted as such in the office of the District Audit Office LFA , organization of Finance Department as indicated under col. 7 against his name from the date of his actual joining in the said post under following terms and conditions. :-

1. His appointment is subject to verification of his character and antecedents by the appropriate Authority. In case an adverse report is received, his services shall be terminated forthwith in accordance with the provisions laid down in sub-clause-I of clause-h of explanation under Rule, 13 of Orissa Civil Services (Classification, Control and Appeal) Rules, 1962.
2. He will be governed by the provisions of Odisha Group B posts (Contractual Appointment) Rules, 2013 and Amendment thereof.
3. Subject to his satisfactory performance, the consolidated monthly remuneration shall be enhanced as per slabs prescribed under Odisha Group-B (Contractual Appointment) Amendment Rules, 2021.
4. On regular appointment, he shall be entitled to draw his pay in level-9 of the pay matrix under ORSP Rules' 2017.
5. He shall be enrolled under the New Pension Scheme contained under Odisha Civil Service (Pension) Rules, 1992 from the date of his contractual appointment

6. He should join in the office of the District Audit Officer as indicated under col. 7 against his name within **thirty days** from the date of issue of this order failing which his appointment stands cancelled automatically. On no account any representation for extension of the date of joining or change in place of posting shall be entertained.

7. He will have to submit the following documents on the date of Joining in the Post.

- (l) Medical Certificate of fitness in the prescribed Form from a Medical Officer not below the rank of an Assistant Surgeon in the State Government Service of Govt. Hospital.
- (m) All Original Certificates in support of educational qualifications and date of birth along with one set of Xerox Copies thereof duly attested by self.
- (n) Character Certificate from two Gazetted Officers not related to him/her (in Annexure-I).
- (o) A Declaration to the effect that he/she has not more than one spouse living in case of married person (in Annexure-II).
- (p) A declaration to the effect that he/she is not prosecuting studies in any educational institution (in Annexure-III).
- (q) A statement showing the movable and immovable property owned by him in the enclosed Form-A prescribed under the Orissa Government Servants Conduct Rules, 1959. This statement should be submitted in a sealed envelope by writing the name, designation and present address and mentioning in bold letters as "PROPERTY STATEMENT" (in Annexure-IV).
- (r) Attestation form duly filled in with two passport size photographs duly attested by a gazetted officer under his seal (in Annexure-V).
- (s) An oath of allegiance to the constitution of India. (in Annexure-VI).
- (t) Original Certificate from competent Medical Authority in support of Physical Disability in case of candidate in P.H. Category.
- (u) Original Discharge Certificate in case of Ex- Service Man.
