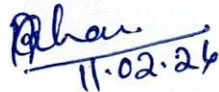
1. Last date for receipt of applications: 28.02.2026

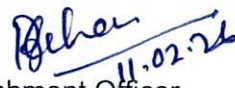

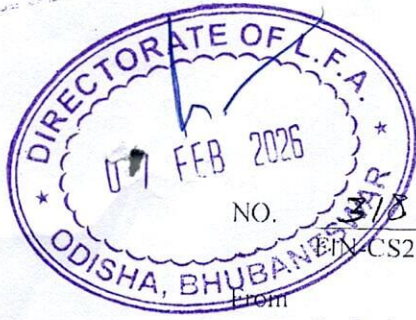

Sub: **Extension of interest-free Electric Vehicle Advance for State Government Employees- reg.**

Madam/Sir,

In inviting a reference to the subject cited above, I am directed to say that State Government have issued guidelines on interest-free Electric Vehicle (EV) Advance in respect of State Government employees vide Finance Department O.M No.8524/F dt.05.04.2022, O.M No.8481/F dt.17.03.2023, letter No.19601/F dt.11.07.2023 and No.28139/F dt.04.10.2024, under which the facility for availing such advance was admissible up to 31st December, 2025, coterminous with the Odisha Electric Vehicle Policy-2021 notified vide C&T (Transport) Department Resolution No.7645 dt.01.09.2021.

2. The validity of the Odisha Electric Vehicle Policy, 2021 has since been extended up to 31st March, 2026 vide C&T (Transport) Department Notification No.16394 dt.31.12.2025.

3. Now, in view of the nearing closure of the financial year 2025-26, the following timelines shall be adhered to for availing interest-free EV advance by State Government employees:

- Last date for receipt of applications: 28th February, 2026.**
- Last date for sanction of advance and release of funds: 10th March, 2026.**
- All other terms & conditions of aforesaid guidelines shall remain unchanged.
