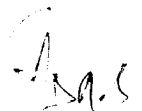

In Pursuance of Judgement dt.24.12.2010 of the Honourable High Court of Odisha passed in WP(C) No. 6781 of 2008 and batch of such cases wherein the Resolution No. 10237/Gen dt.20.03.2002 of Govt. of Odisha in G.A. 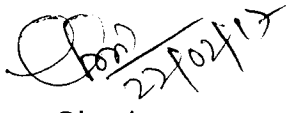

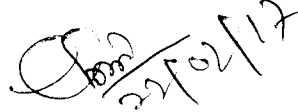

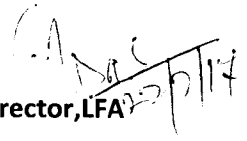
