Madam/Sir,

In this connection, it is hereby clarified that instructions communicated to all Departments vide the above-referred letter **shall not be applicable in case of** SNA Bank accounts, payment aggregator/payment gateway bank accounts, Agency bank accounts (for collection of State Government dues) and NPS/Pension trustee bank accounts currently maintained in HDFC Bank, ICICI Bank and Axis Bank. However, while the above-mentioned bank accounts of State Government organisations shall continue in these three banks, new accounts for these purposes shall not be opened in these three banks till further order.
