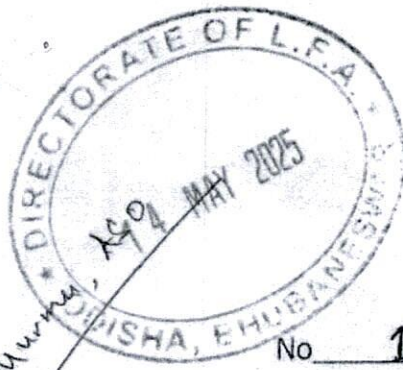
It is applicable for officers of Odisha Finance Service (OFS) Cadre, officers of Odisha Taxation & Accounts Service (OT&AS) Cadre and officers of Odisha Sub-ordinate Finance Service Cadre under administrative control of Finance Department.

Online submission of transfer representation is hereby made mandatory with immediate effect. No hardcopy or physical representation for transfer shall be entertained henceforth. Hardcopy or physical transfer representations/grievances already received or will be received in future shall not be entertained at all and the concerned employees are required to submit their representation afresh in online mode between **20th May, 2025 - 30th June, 2025**.

Further, no employee of the aforementioned Cadres shall visit any higher authority for submitting transfer representations or for pursuing his/her transfer.

This will come into effect immediately.


