



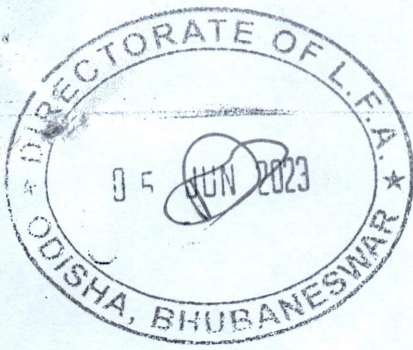

Sub: Recommendation of Non-State Civil Service Officers for their consideration for appointment to IAS of Odisha Cadre by selection during 2023 against the Select List - 2022.

Sir/Madam,

I am directed to say that in accordance with the provisions contained in subrule (2) of rule 8 of the IAS (Recruitment) Rules, 1954, the State Government from time to time consider the cases of officers not belonging to the State Civil Service, but serving in connection with the affairs of the State for appointment to IAS by selection. Four (4) vacancies in the selection quota meant for NSCS officers against Select List -2022 shall be filled up from among the suitable and willing NSCS officers during 2023.

The eligibility criteria of the officers are as follows:-

- (a) The officers should be of outstanding merit and ability;
- (b) They should have completed not less than eight(8) years of continuous service under the State Government as on the first day of January, 2022 in a Group-A post which has been declared equivalent to the post of Deputy Collector in the state civil service and have held that post in a substantive capacity as on 01.01.2022;
- (c) They should not have attained the age of 56 years on the 1st c. day of January, 2022;
- (d) The officers should be free from disciplinary proceedings / criminal cases / vigilance cases etc.

It is, therefore, requested to circulate the same among the eligible officers under their administrative control with a request to the willing officers to submit their applications through the cadre controlling department with an advance copy to the Services-I Section of GA & PG Department within 20 days. Further, the cadre controlling department is requested to kindly scrutinise the applications and recommend the names of eligible and willing NSCS officers working in / under their Department alongwith their service particulars in the enclosed proforma with relevant documents and their willingness duly authenticated by the competent authority of their Department by 26.06.2023 for consideration of their names for appointment to IAS by selection against Select List-2022.
