Sub: Allowances admissible to the contractual employees working under MGNREGS.

Madam/Sir,

Pursuant to the the recommendation of the Governing Body of MGNREGS Odisha Society in its meeting held on 11.02.2020, Government in PR & DW Department has been pleased to approve the following allowances in favour of the contractual employees engaged under MGNREGS.

1. Travel Allowances (TA) & Daily Allowances (DA) of Field Level functionaries:

i. TA & DA for MGNREGS Co-ordinators (MCs) and Additional Programme Officers(APOs):

TA, DA and other Travelling Expenses to the MCs & APOs engaged under MGNREGS will be reimbursed at the following rate.

Mode of Travel for tour outside the State	By Train (3 rd AC)	
D.A (Outside State)	Rs.320/- per day	
D.A (Inside State)	Rs.140/- per day	
Outside State accommodation	Rs.1500/- per day maximum or as per actual.	

Inside State accommodation	Rs.800/- per day maximum or as per actual.
Maximum local travel conveyance for tour within state against production of bill/ invoice (if conveyance not provided)	By 3 rd AC/ Super fast Bus
Maximum local travel conveyance for tour outside state against production of bill/ invoice.	Rs.400/- Maximum (as per actual)

ii. TA & DA for Gram Rozgar Sevaks (GRSs):-

TA, DA and other Travelling Expenses to the **GRSs** engaged under MGNREGS will be reimbursed at the following rate.

Mode of Travel for tour outside the State	By Train (Sleeper)	
D.A (Outside State)	Rs.300/- per day	
D.A (Inside State)	Rs.120/- per day	
Outside State accommodation	Rs.1000/- per day maximum or as per actual.	
Inside State accommodation	Rs.500/- per day maximum or as per actual.	
Maximum local travel conveyance for tour within state against production of bill/ invoice (if conveyance not provided)	Sleeper Class/ Express Bus	
Maximum local travel conveyance for tour outside state against production of bill/ invoice.	Rs.300/- Maximum (as per actual)	

2. Mobile Phone Allowance:- Mobile Phone Allowances is admissible to the MGNREGS functionaries at the following rate.

Sl. No.	MGNREGS functionaries	Mobile Phone Allowance Amount
1	MGNREGA Co-ordinators, APOs and GRSs	Rs.500/- per month

 The functionaries those have availed Cell Phone shall not be entitled for mobile phone allowances. The instruction communicated vide Office Order No. 5890 dated 23.03.2018 allowing the MCs for purchase of smart phone is hereby superseded with immediate effect.

- The expenditure towards Travel Allowances and Mobile Allowances will be borne out of Administrative Contingency available in their respective Administrative units.
- The Travel Allowances and Mobile Allowances will be effective from 01.04.2020.
