**Sub: Leave Travel Concession – clarification regarding.**

Subsequent to issue of F.D. Office Memorandum No.21730/F dated 16.06.1994 providing the benefit of Leave Travel Concession to Government Servants to visit any place of interest within the territory of India, Government have been pleased to allow the facility of LTC once in 10 (ten) years subject to maximum of 3 (three) times during the entire service period of a Government Servant as per F.D. O.M. No.27131/F dated 16.06.1999. At a later stage, Government Servants were allowed to undertake air journey for the purpose of LTC subject to stipulations that reimbursement of the cost of journey under the LTC scheme shall be limited to the fare as per entitlement of the employee concerned had he/she travelled by rail, road, steamer, or ship as per F.D. O.M. No.31397/F dated 16.07.2011.

Consequent upon revision of Pay Scales of Government Servants with effect from 01.01.2006 under ORSP Rules 2008, Government after careful consideration have been pleased to clarify that the grades of Government Servants as stipulated in para-1 of Finance Department O.M. No.16638/F, dated 02.04.2011, will also be applicable to decide the grade of the Government Servant for the purpose of Leave Travel Concession. The entitlements for journey by train/ road/ sea or steamer as applicable to different grades of Government Servants as stipulated in para-6 of F.D. O.M. No.21730/F dated 16.04.1994 will continue to apply for availing LTC by them.
