OFFICE ORDER

In pursuance of the provisions of Odisha Group-C & Group-D Posts (Contractual Appointment) Rule, 2013 notified vide Govt. in G.A. 1. His appointment is subject to verification of their character and antecedents by the appropriate Authority. In case an adverse report is received, his services shall be terminated forthwith in accordance with the provisions laid down in sub-clause-I of clause-h of explanation under Rule, 13 of Orissa Civil Services (Classification, Control and Appeal) Rules, 1962.

2. He will be governed by the provisions of Odisha Group-C & Group-D posts (Contractual Appointment) Rules, 2013 and Amendment thereof.

- (h) An oath of allegiance to the Constitution of India. (in Annexure-VI)..
