Sir.

Information on funds parked in different Bank accounts are asked in Public Accounts Committee as well as in form of Assembly Questions and also on amount deposited back in government consolidated funds. Collection of such information within short span of time is often not possible. Further, for prudent financial management, it is required to have information on all funds lying in bank accounts.

- 2. In order to collect the information from all the Departments, a module is created in http://onlinebudget.gov.in/BETA. This facility will enable the consolidation of data, ensuring accurate and timely insights into the state's financial position outside the treasury. Submission of information in BETA is made mandatory for all Departments before submission of Annual Budget, 2026-27.
- 3. It is therefore requested to collect information from all establishments where government funds given from the budget to state agencies including inter-alia Directorates, Commissionerates or any other Government Organizations such as PSUs, Societies, Universities, ULBs and PRIs under your jurisdiction in the enclosed format and submit the same to this Department through BETA using login credentials by 31.10.2025 positively.
